

Caroline Elisabeth HORNSTEIN TOMIĆ, PhD

Caroline Hornstein Tomić (born 1968 in Heidelberg, married, two children) holds an MA in Cultural Anthropology/European Ethnology and a doctoral degree in Sociology from Goethe University/Frankfurt am Main. She is working at Ivo Pilar Institute of Social Sciences in Zagreb since 2008 (permanent resident in Croatia; German citizenship). A Senior Research Associate with expertise in international migration and related policies (skilled migration and development, brain drain/gain/circulation, knowledge/culture transfers), social integration and identity (politics), and state building and transformation processes in CEE, Caroline Hornstein Tomić has been (team-) leading two international research projects: *Remigrations and transitions in post-socialist European regions* (since 2013, funded by ERSTE Foundation; *Transitions in Central and South Eastern Europe: Changing Gender Perspectives* (2008–2011, funded by ERSTE Foundation); she has conducted research on *Interethnic relations in Southeast Europe* (2007–2008, funded by Konrad Adenauer Foundation), and she participated as researcher in several international and national research projects dealing with interethnic relations and state building processes in SEE, multiculturalism and citizenship regimes in Europe and Germany respectively. Since 2010, she is teaching as external lecturer (Assistant Professor) at the Chair for Anthropology/Zagreb University the obligatory graduate course „Culture and Identity“ (in English) and mentoring graduate students (Masters and Diploma).

In 2000 Caroline Hornstein Tomić joined the foreign service of Konrad Adenauer Foundation, and headed the country office Bosnia and Herzegovina from 2001 until 2005. She has since been engaged as researcher, consultant, evaluator/peer reviewer for scientific and expert projects, programs and publications, commissioned by organisations such as United Nations Development Project (UNDP), Konrad Adenauer Foundation (KAS), Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ), Goethe Institute, ERSTE Foundation, German Council on Foreign Relations (DGAP), Federal Agency for Civic Education (bpb), Ministry of Science and Education of the Republic of Croatia (MZOS), Swiss Embassy in Croatia; and as interview partner for local and foreign media.

Caroline Hornstein Tomić has written two monographies (the first published in 1995 on 2nd generation migrants, naturalization policies in Germany and European citizenship regimes; the second on problems of intercultural understanding and anthropological discourses about representation, identity and knowledge production). She has been editorial board member for six scientific publications (five books – one in preparation -, one journal), wrote twelve book contributions, two articles in international journals (one current content), as well as seven expert studies (third sources funded). For her doctoral research she received a Konrad Adenauer Foundation doctoral fellowship/grant (1997-2000), as well as a grant for research at Massachusetts Institute of Technology (MIT) / Social and Cultural Studies of Science and Technology (STS) in Cambridge/USA in 1996/97. She was awarded with “*magna cum laude*” for her Doctorate (defense “*summa cum laude*”), and received an honors award for her Masters Degree. Caroline Hornstein Tomić is regularly lecturing and presenting at international conferences and expert meetings, and since 2008 she has been organizing in Croatia sixteen conferences and lectures with international academic experts as head (7 times) and as member (9 times) of the organizing board, and outside Croatia several international workshops.

Caroline Hornstein Tomić is one of the founders and manages the strategic development of the *Stiftung Wissen am Werk / Zaklada znanje na djelu* (Foundation Knowledge in practice). Since 2013 she is Member of the NEWFELPRO Selection Board (FP7 Marie Curie funded scholarship program of the Croatian Ministry of Science and Education), and since 2005 Member of the Advisory Board of ERSTE Stiftung. Other memberships: European Association of Social Anthropologists (EASA); Hrvatsko Sociološko Društvo (HSD); Societé Internationale d'Ethnologie et de Folklore (SIEF).
