Theol. Fakultät Bonn; Gastprofessuren in Marburg, Bamberg, Wien, Jerusalem und Rom, 1993 Habilitation; 1988 Promotion; Studium der Katholischen Theologie, geboren 1957 in Bad Aussee.

**Larissa Hrotkó**, deutsch-russischer Abstammung, geboren am 27. Februar 1945. Seit 1972 lebt sie in Ungarn. Sie hat Sprachwissenschaft, Theologie und jüdische Kulturanthropologie studiert. Anschließend hat sie die Doktorschule am Rabbiner-Institut in Budapest absolviert. Zurzeit steht sie vor der Promotion, ihr Forschungsthema ist Ansiedlung der Juden in Pest im 18-19. Jahrhundert von Frauensicht aus.

**Lisa Isherwood** is a liberation theologian who believes theology to be a communal project fuelled by notions of radical equality and empowered by divine companionship. Her work explores the nature of incarnation within a contemporary context and includes such areas as the body, gender, sexuality and eco-theology. She has written, co-authored or edited 19 books such as *The Power of Erotic Celibacy* (T&T Clark, 2006); *The Fat Jesus: Feminist Explorations in Boundaries and Transgressions* (DLT, 2007); *Introducing Feminist Christologies* (Continuum, 2001); *Liberating Christ* (Pilgrim Press 1999) and *Patriarchs, Prophets and Other Villains* (ed) (Equinox, 2007). She has been series editor of five international series *Introductions in Feminist Theology* (Continuum); *Queer Theology* (T&T Clark co-editor Marcella Althaus-Reid); *Theology, Gender & Spirituality* (Equinox); *Religion & Violence* (Equinox) and *Controversies in Contextual Theology* (SCM), co-editor Marcella Althaus-Reid. Professor Isherwood is an Executive Editor and founding editor of the international journal 'Feminist Theology'. From 2007-2009 she was Vice President of the European Society of Women in Theological Research.

**Joanna Kiersztein** is a biblical scholar as well as a theatrical director. For the past 13 years, she has staged lots of plays from Shakespeare to Ionesco, often trying to join art-house theatre and Christian themes. Nowadays, she is working on her doctoral thesis about doctrinal and moral threats in an early Christian community from the perspective of Catholic Letters of the New Testament.
