**Predrag Bejaković** is a Ph.D. economist who acts as an advisor to the Institute of Public Finance in Zagreb. He has more than 20 years of experience analysing tax policy, statistics on economic development, and employment. Dr. Bejaković has written more than 50 scientific articles on such topics as the informal economy, local economic development, legal protection of the unemployed, tax administration, privatization, and democracy. Dr. Bejaković has lectured on economic development worldwide, including Denmark, the United States, and Hungary. He served as a Fulbright scholar at the University of Madison, Wisconsin, and participated in postdoctoral upgrading on University of Essex and Centre for Fiscal Studies, Bath, Great Britain as British Council Chevening scholar. Recently he was project manager in the project *The Reform of the Pension System and Sustainable Budget*, ordered by the Ministry of Science of the Republic of Croatia, and collaborated in the project *The Unofficial Economy In the Republic Of Croatia*, ordered by the Ministry of Finance of the Republic of Croatia.

**Svenn-Åge Dahl** is a sociologist and researcher at the Institute for Research in Economics and Business Administration (SNF) in Bergen, Norway. He is also working as a research director for the *Programme on Welfare Research* organised by the Research Council of Norway. His research interests are mainly within the sociology of labour markets and social insurance. He has publications in journals like *Acta Sociologica*, *Scandinavian Journal of Management*, *Applied Economics*, *European Sociological Review* and chapters in several books. The last years he has been working mostly with different aspects of early retirement, sickness absence and vocational rehabilitation.

**Javier Ramos-Diaz** is a researcher at the Juan March Institute (Madrid) and at the European University Insti-

tute (Florence). His main interests include employment and poverty. He has published on new patterns of employment, income distribution among the employed labour force and the adequacy of social protection for unemployed in several European countries. His current research (doctoral dissertation) focuses on low pay employment from a household perspective.

**Matthieu de Nanteuil-Miribel** is a professor of sociology at University of Louvain, Belgium. His fields of research are changes in forms of work and employment in Europe, the relationships between work, recognition and identity in modern societies, as well as the links between philosophy and sociology. **Simon Roberts** is a researcher at the Centre for Research in Social Policy (CRSP) at Loughborough University in the UK. Dr. Roberts' research experience includes UK, European and international social security; minimum income policies; migration and social security; international comparisons of public management reforms; the application of Business Process Re-engineering to the UK National Health Service; and performance audit. Dr. Roberts is the Project Leader of the ISSA study “*Assessing the coverage gap*” examining coverage of social security and healthcare provision in fifteen countries around the world. He is the UK expert on the European Commission's “*Observatory on Social Security for Migrant Workers*” and a member of the European Commission's Working Group looking at the impact of globalisation on European social security systems.

**Pascale Vielle** is professor of law at Faculté de droit, Université catholique de Louvain, Belgium. Her field of research is social security law and labour law. She has obtained her Ph.D. in law from the European University Institute in Florence. She has published several articles in journals and books, and also edited two books. **Jelle Visser** is a professor of empirical sociology and holds the chair of Sociology of Work and Organization at the University of Amsterdam, where he acts as Scientific Director of the Amsterdam Institute of Advanced Labour Studies (AIAS), an interdisciplinary research centre of economists, sociologists, psychologists and lawyers. He was associated with the Max Planck Institute for the Study of Societies in Cologne, Germany, and has acted as consultant to the Organisation of Economic Co-operation and Development and the International Labour Organisation. He was member of the High Level Group of the European Commission on implementing the Lisbon Strategy in Industrial Relations. His recent books (in English) include: *The Role of the Unions in the 21<sup>st</sup> Century* (2001, with Tito Boeri, Lars Calmfors and others, Oxford University Press), *Trade Unions in Western Europe Since 1945* (2000, with Bernhard Ebbinghaus, Macmillan), *"A Dutch Miracle": Job Growth, Welfare Reform and Corporatism in the Netherlands* (1997, with Anton Hemerijck, Amsterdam University Press), *Industrial Relations in Europe: Traditions and Transitions* (1996, with Joris van Ruysseveldt, Sage), and *In Search of Inclusive Unionism* (1990, Kluwer and Bulletin of Comparative Labour Relations).

**Nino Žganec** is Minister Assistant at the Ministry of Labour and Social Welfare within the Government of the Republic of Croatia and a lecturer at the Department of Social Welfare of the Faculty of Law, University of Zagreb. He has earned his doctoral degree at the Faculty of Education and Rehabilitation and the title of his dissertation is *"Organising Local Community for the Prevention of Behavioural Disorders in Children and Youth"*. He has completed a four-year postgraduate study in Family Therapy at the Institute for Family Therapy and Family Counselling in Graz, Austria and is listed in the European Register of Psychotherapists. From the beginning of the Homeland War he was actively involved in the provision of different forms of psychosocial assistance to displaced persons and refugees within various humanitarian organisations.
