

## ABOUT THE AUTHORS

Martin BELL, London, Great Britain. He studied in Cambridge (1962) and was employed in *BBC*. For more than 30 years he had reported from over 80 countries, 11 of which were in an armed conflict. After his reports from the war in Vietnam he became one of the most respected world names in war journalism. He was reporting from Vukovar and directly witnessed to the crimes of Serbian Army. Mr. Bell was awarded with several awards and recognitions.

Janusz BUGAJSKI, Washington, USA. Director of *East European Studies* at the *Centre for Strategic and International Studies* in Washington. He was the editor of the *Radio Free Europe* in Munich, and consultant and lecturer at several agencies, institutes and projects in USA. Bugajski is the author of several books dealing with ethnic and political topics in the East Europe and wrote numerous articles for the media. He was awarded with several awards and recognitions for his work.

**Ivan ČIZMIĆ**, Ph.D., Zagreb, Croatia. Research Advisor at the *Ivo Pilar Institute of Social Sciences*, a historian and a lawyer. His research interests are Croatian emigration and he is the author of several books, studies and articles on the topic. He cooperated in a number of international and national projects and scientific symposia.

Luc HUYSE, Leuven, Belgium. Until his retirement (in 2000) he was professor of sociology and sociology of law at the *Leuven University Law School*. He was consultant to governement and non-governmental organizations in Burundi and Ethiopia, and has written extensively on the consolidation of young democracies. Zlatko KARAČ, Zagreb, Croatia. He teaches at the *Department of Town Planning* of the Faculty of Architecture in Zagreb. He is preparing a doctoral thesis on the topic of urban development of Vukovar. Mr. Karač was a member of the expert negotiating team for the city of Vukovar. Currently, he is a member of the *Government Committee for the Restoration of Culture of the City of Vukovar* and conducts conservation and restoration research of the historical core of Vukovar. Mr. Karač has published more than hundred scientific and professional papers.

**Paul LEMMENS** teaches a course on human rights at the Catholic University of Leuven, Belgium. He is Director of the *European Postgraduate Programme on Human Rights and democratization*, based in Venice, Italy.
