ABOUT THE AUTHORS

Alica Wertheimer-Baletić (1937), academician, university professor at the Faculty of Economics in Zagreb and regular member of the Croatian Academy of Sciences and Arts. The school year 1966/67 she spent in the United States, at the University of Chicago. She teaches courses in demography in regular study programmes and at postgraduate study, and periodically lectures on specific topics (in Zagreb, Osijek, Sarajevo, at the Study Centre for Social Work at the Faculty of Law, University in Zagreb, etc). In the period 1968-1972, she was a Head of the Department of Demography at the Institute for Social Researches, University of Zagreb. She was also a Head of the Department of Demography at the Faculty of Economics, University of Zagreb. Participated in numerous domestic and international research projects and conferences on population. The author of more than 150 scientific and professional papers and publications - books, articles, discussions and research expertises.

Agneza Szabo, Ph.D. graduated History at the Faculty of Philosophy, University of Zagreb. She earned her M.Sc. degree at the same Faculty in 1978, and Ph.D. degree in 1983. Since 1985, a senior research assistant. She was employed at the Zagreb City Museum and in the period 1981-1994 she was external collaborator at the Croatian Institute of History of the University of Zagreb. Since then she has been engaged in the scientific project for the Humanistic Sciences at the Croatian Academy of Sciences and Arts (external collaborator). From 1992 to 2000 she acted as a collaborating expert for history handbooks at the Ministry of Education at the Republic of Croatia and was the author of the curriculum for teaching history in primary and secondary schools. She was also a collaborator of the Croatian Radio and a permanent member of several professional associations. Received several public recognitions and awards, such as "Josip Juraj Strossmayer"

She has devoted special attention to social structure of the 19<sup>th</sup>-century population including problem of depopulation in historical demography, particularly in the late 19<sup>th</sup> and early 20<sup>th</sup> century.

Ivan Čizmić (1934), Ph.D. a historian and research advisor at the Ivo Pilar Institute of Social Sciences. The fields of his scientific interest are: social history, emigration and immigration and political history. He is the author of five books from the history of the Croatian emigration and more than fifty scientific and professional papers. He has participated in several dozens of scientific meeting in Croatia and abroad.

**Dražen Živić** (1968), Ph.D., a research associate at the Ivo Pilar Institute of Social Sciences. His primary focus of scientific interest is demography, in particular the development of Croatian population and demographic consequences of the Homeland War. Participated in a number of Institute's scientific projects and in dozens of scientific and professional meetings in Croatia and abroad. He is the principal investigator on the scientific project "Demographic losses and Consequences of the Homeland War". Published about fifty scientific and professional papers. Teaches *Demography* and *Demographic Tendencies in Croatia in the 20<sup>th</sup> Century* at the Croatian Studies (programme: Sociology). In 2001 he received the State Award for Science for young scientists in the field of social sciences.

Anđelko Akrap (1954), Ph.D., an associate professor at the Department for Demography, Faculty of Economics University of Zagreb. His particular interests are regional demographic problems in Croatia. Published more than forty scientific and professional papers and two books as a co-author.

Nenad Pokos (1965) Ph.D., a demographer and research associate at the Ivo Pilar Institute of Social Sciences. He participated in or worked independently on the number of research Institute projects. Published more than thirty scientific and professional papers in the field of demography. At the Croatian Studies (programme: Sociol-

ogy) he teaches *Demography* and *Demographic Tendencies in Croatia in the 20<sup>th</sup> Century.* 

Gordan Črpić (1966) M.Sc., employed at the Center for Promotion of the Social Teachings of the Church established by the Croatian Conference on Bishops. He graduated Sociology, Theology and Electrical Engineering. He earned his M.Sc. degree in sociology, in the field Sociology of Religion. His research interest is sociology of religion. He also devoted a lot of attention to demographic aspects and family policy.

**Snježana Mrđen** (1956) Ph.D., is an assistant professor at the Department for Geography, University in Zadar. She received her bachelor and M.Sc. degrees from the Department for Geography at the Faculty of Science, Univer-

sity in Zagreb (field: demogeography). She received her Ph.D. at the École des Hautes Etudes en Sciences Sociales in Paris and earned the title of a Doctor in Demography and Social Sciences. Specialized at the Institut National d'Etudes Démographiques in Paris for five years (1990 - 1994) where she spent the years 1998 and 1999 as a visiting scientist. The author of more than 15 scientific and professional papers and publications in the field of demography published in the country and abroad. Marinko Grizelj actively participates in state statistics and in early nineties he was a coordinator of the project Demographic Trends and Processes in the Territory of Former SFRY. In that period he was a member of the Working Group for the Development of the Strategy of Croatia at the Ministry of Development and Reconstruction. After the Homeland War he works jointly with a group of demographers at the Ivo Pilar Institute of Social Sciences on the project "Trends of the Total Number of Inhabitants in the Republic of Croatia since 1991 Census to 1998 and Quantification of Selected Components. He is the Head of the Working Group for Population Projections of the Croatian Population at the Croatian Bureau for Statistics.

Participated in international meetings in Budapest (1988) in the Hague Forum (1999) and the UN General Assembly Special Conference(1999) – dedicated to the implementation of the Program of Action of the International Conference on Population and Development, held in Cairo 1994. Wrote a number of texts, majority of which refer to demographic and family problems. As a tutor he participated in 1991 and 2001 censuses. Held a series of lectures and participated in round table discussions as well as in radio and TV programs addressing primarily demographic and family topics.
