Reception

The **European Council for Foreign Relations (ECFR)** - a Berlin based think tank with a European-wide network in politics, public administration, academia, and the media - conducts a bi-annual expert poll among EU professionals in all 28 member states, the EU Coalition Explorer (<https://www.ecfr.eu/eucoalitionexplorer>). The EU Coalition Explorer is a data-based instrument and interactive visualization tool which allows analyzing cooperation and networking behavior of all 28 EU member states. It shows the current cooperation patterns and policy priorities of governments as well as their partnership preferences for the coming years. In that, this set of data is of practical relevance to those crafting partnership strategies in capitals across the EU. Clearly, cooperation between member states is key to a functioning European Union; however, the latest edition of the EU Coalition Explorer reveals that there is still much room for EU capitals to improve their strategies for building coalitions in achieving common goals. In 2018, more than 800 policy professionals responded to the online questionnaire, sharing their perceptions and experience of interaction between EU governments. The recent findings published in 2018 have stirred a controversial debate in the Croatian public and the media, since they point at unused potential for policy coordination and strategic partnership building between Croatia as youngest EU member with fellow member states.

Talking Europe II

2019 - 2020

With *Talking Europe*, the Institute of Social Sciences Ivo Pilar in Zagreb organized a series of seven public lectures and panel debates in 2010 and 2011 during the run-up to Croatia's accession to the European Union. The series was organized in partnership with the Croatia Office of Konrad-Adenauer-Stiftung. For each panel a foreign guest (from academia, politics, or think tanks) was invited as a speaker; whereas the panelists and discussants were from different Croatian scientific and public institutions, as well as from the Ivo Pilar Institute. The series tackled topics ranging from EU enlargement, demographic developments, European social systems, identity / alterity, European centers and peripheries, to the Euro crisis, and finally, how to complete SOE-integration into the European Union.

Talking Europe II 2019 - 2020 will resume and continue the debate on current challenges and future perspectives of the European Union, this time in the run-up to European parliament elections and Croatia's EU Council Presidency. *Talking Europe II* again will be organized in partnership with the Croatia Office of Konrad-Adenauer-Stiftung, as well as with the Institute for Development and International Relations (IRMO) as the third partner. Again, a cross-institutional, interdisciplinary and international principle of organization will be followed: each panel will be hosted by a scientist from Pilar Institute who will convene speakers from foreign / international academic and public institutions, including stakeholders from think tanks, international organizations, or industry, with panelists from Croatia. Thus, the series continues to encourage dialogue on issues of relevance both on local as well as supranational / European levels; and the panels strive, not only for academic expertise but also, for cross-sectorial and controversial debate from multiple perspectives for quality criteria. *Talking Europe II* consists of three panel debates per year.
